MSIA EXECUTIVE TEAM MEETING January 9, 2018

On January 9, 2018 MSIA Executive Committee meeting was held at 11:30 a.m. in Jefferson City at the Department of Labor Relations. Larry Fish called the meeting to order.

- Treasurer's Report
 - Dwight reported we currently have \$ 3,421.61 in the checking account and \$15,518.40 in the Money Market account, as of January 9, 2018 John moved to approve this report and Matt seconded.

 - Matt will teach the Firearms Course. Will plan to meet at the Range in March to check it out.
 - Banquet Speaker, possibly DPS Director, Charles Juden – Dwight will check with him.
 - Denetta will correct the schedule and send it out to the Board.
- John will work on the Trademark application, which cost \$25, still needs to be completed.
- Raffle – Nick is in talks with Pistol's Plus and one other vendor for guns for raffle.
 - We will look into getting a handgun and rifle.
 - Vendor products for raffle or door prizes.
 - Flag from the capital.
- Scholarship for smaller agencies that have officer's needing the training, with less than 5 or less full-time Officer's.
 - Discussion was made to choose 1 from each quadrant (I-70/63 Highway split). 1 Officer from agencies that have not been in the last 3 years. Must provide an application for consideration. Denetta makes a motion that we provide a scholarship for up to 4 agencies, Dwight seconded, motion passed. Deadline for applications will be April 1, 2018.
